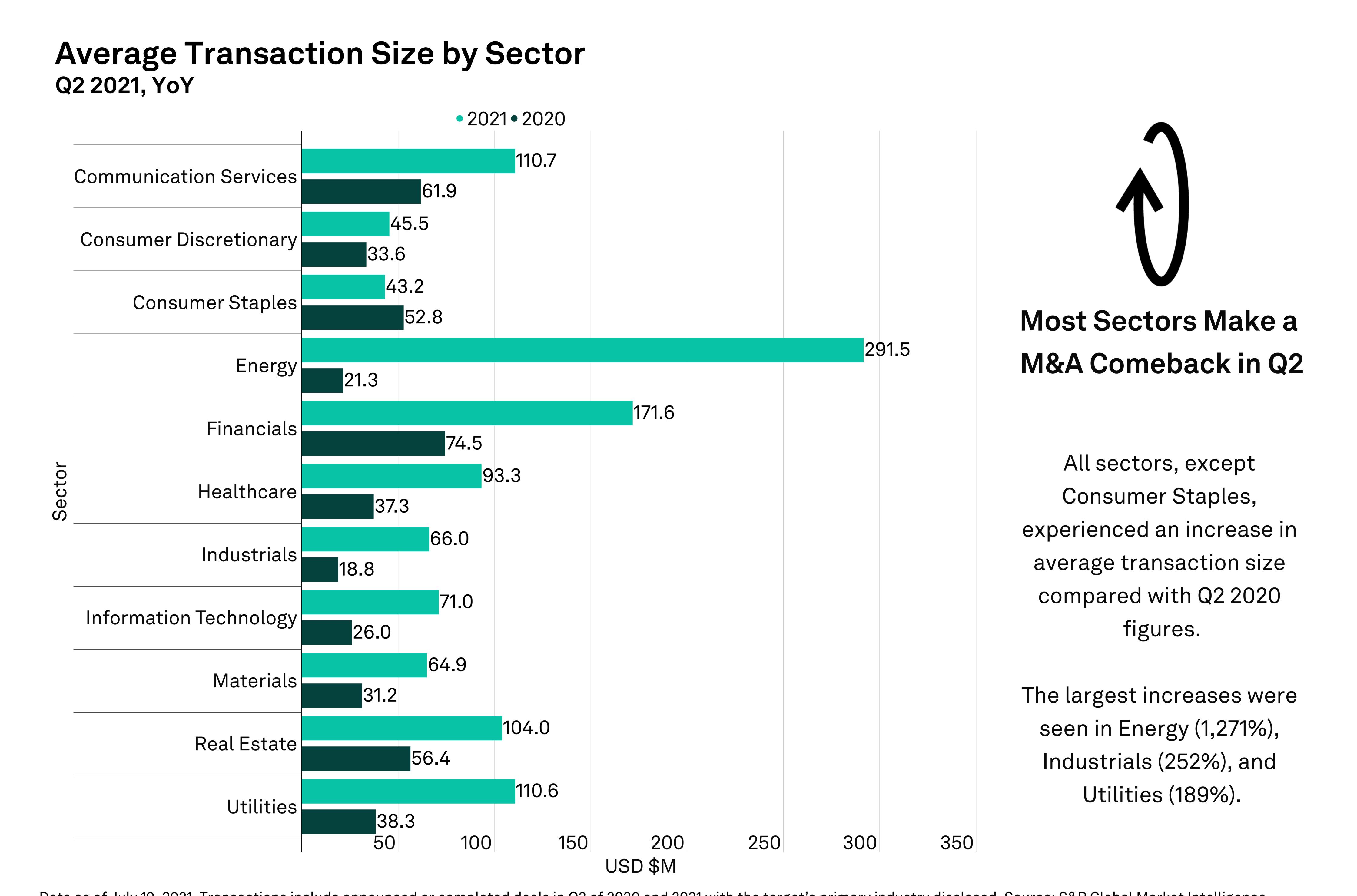
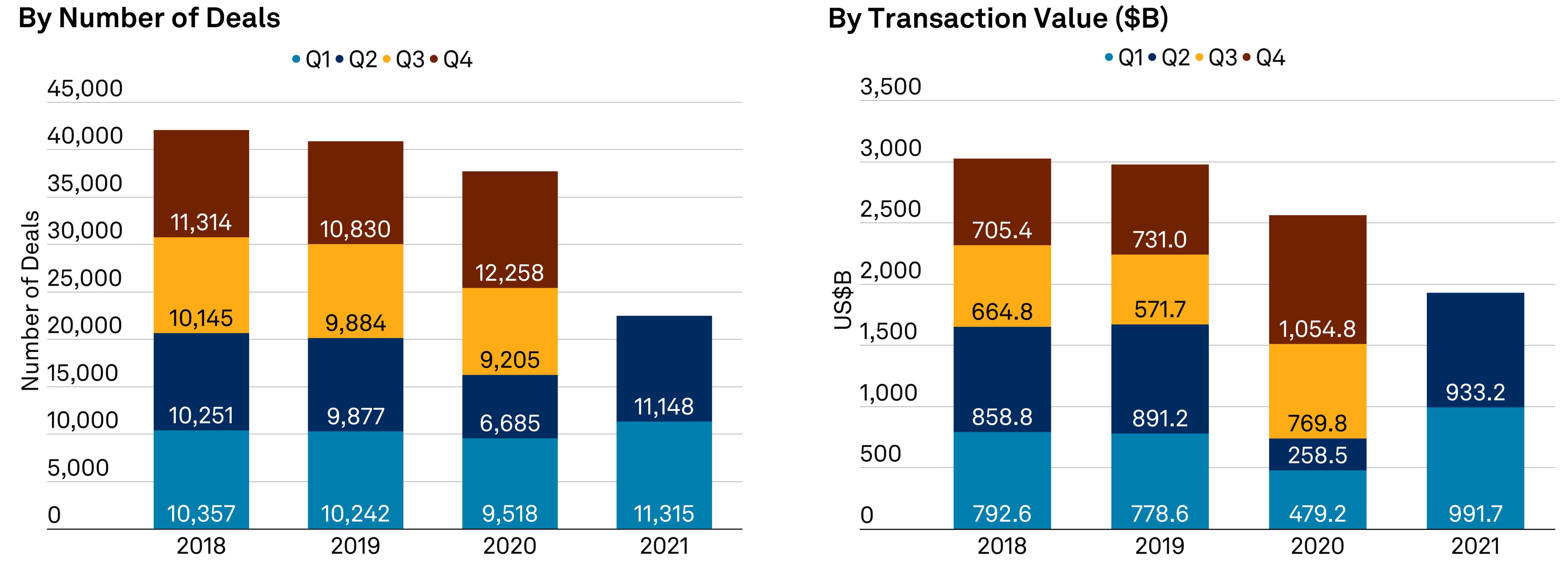
# Global M&A By the Numbers: Q2 2021

Momentum in Q2, looking at M&A deal size and volumes, remained at consistent levels versus Q1 as signs of sustained recovery from the pandemic continued. ## Global M&A Activity



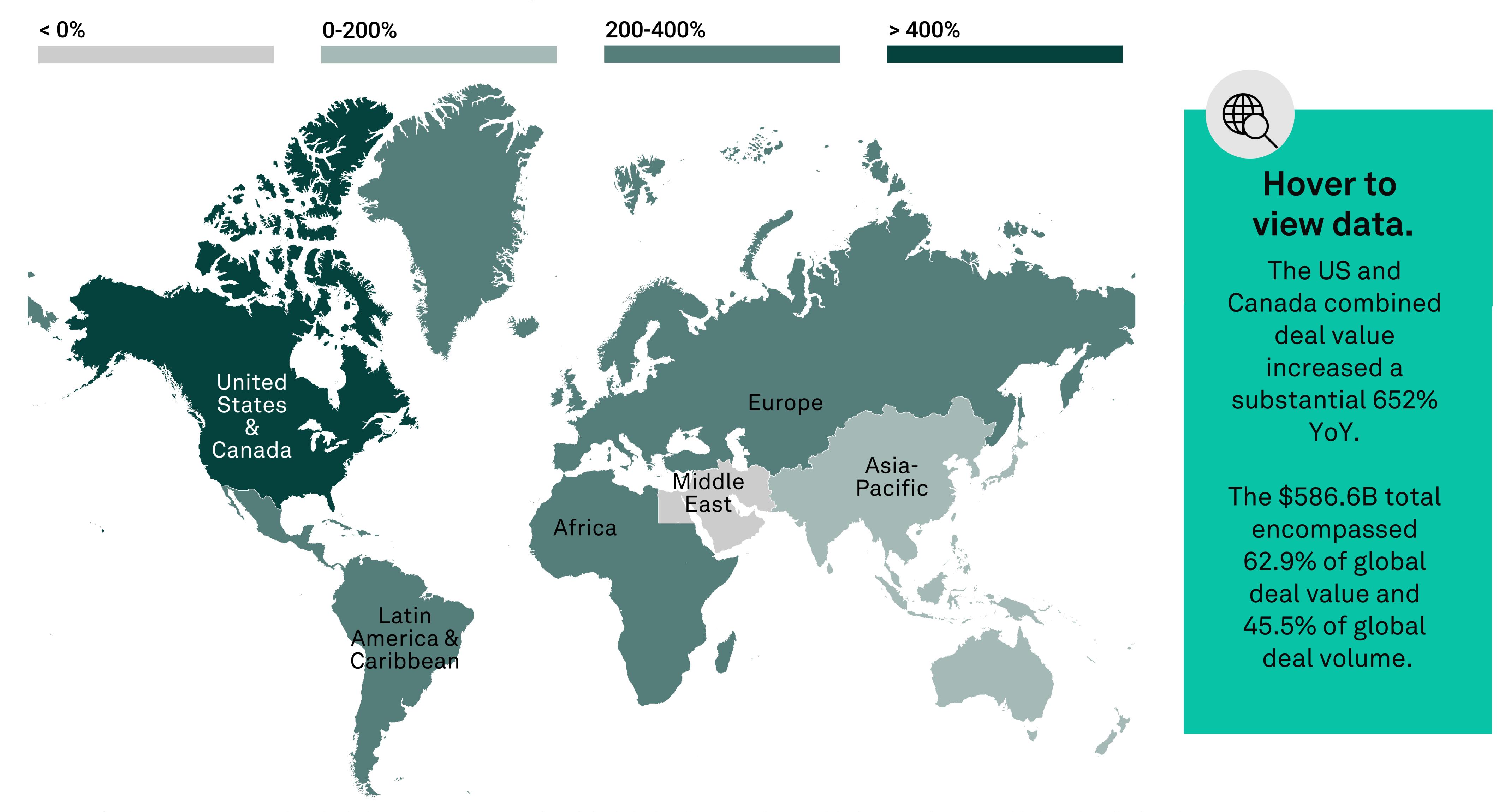

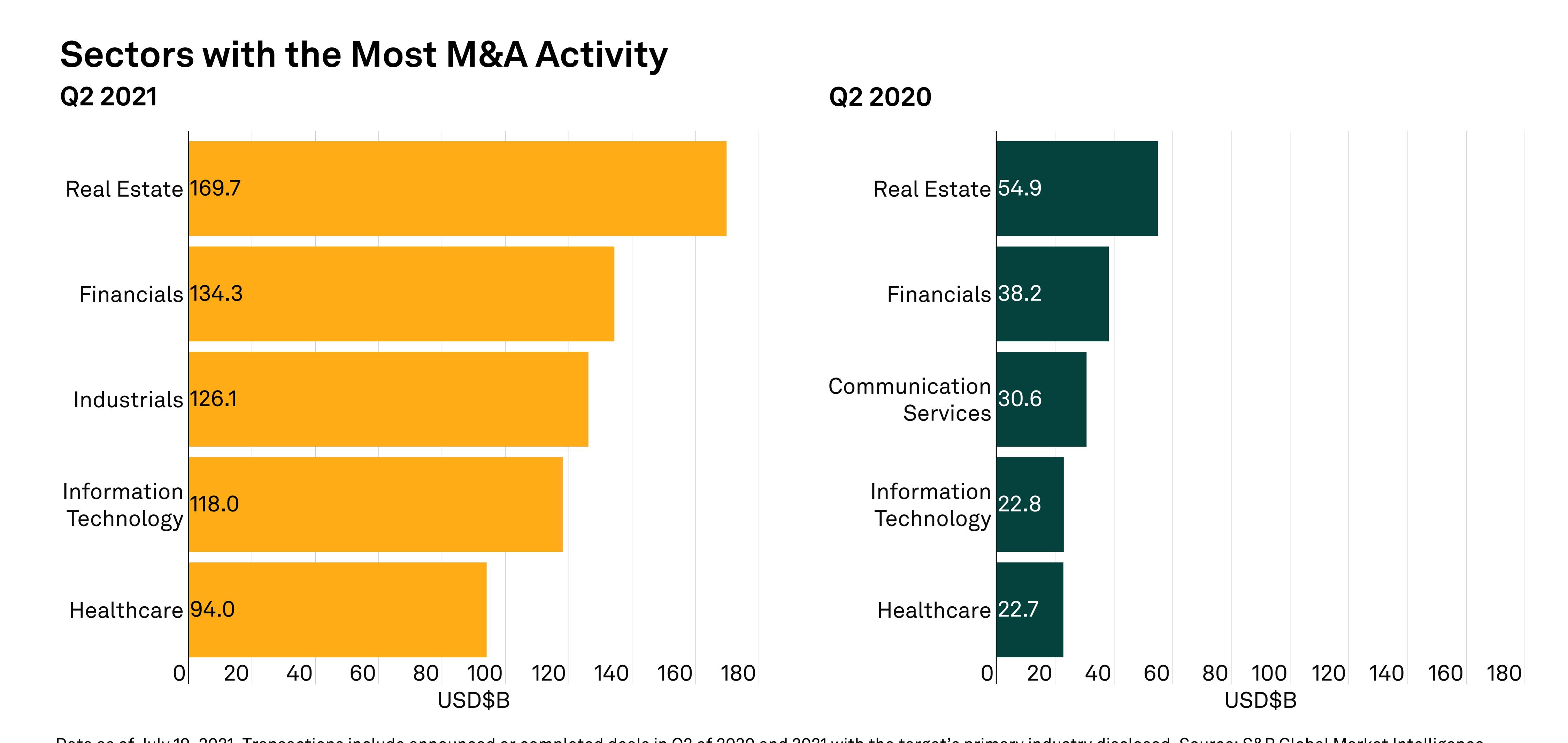

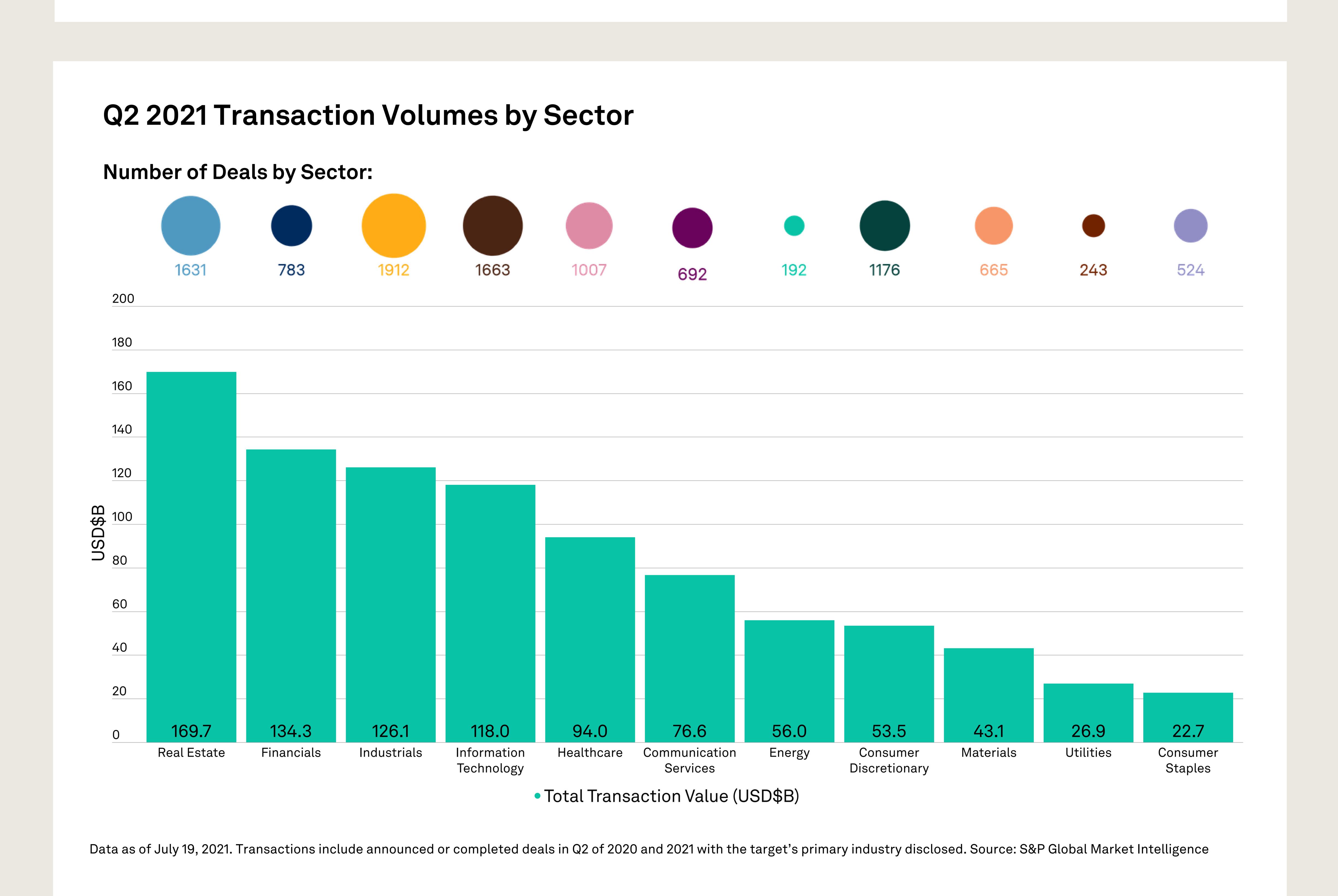
